## **Motel Policy**

- 1. Check-in time is 3:00 pm. Check-out time is 11:00 am.
- 2. The check-out time can be extended to 12:00 pm upon request. After 12:00 pm, one more night will be charged.
- 3. The registered guest responsible for the room must be at least 18 years of age.
- 4. Payment must be made upon check-in.
- 5. Twilight Country Motel is a non-smoking facility. A \$350 smoking fee will be charged for smoking in the guest rooms.
- 6. When checking in, a \$300 damage deposit is required if you want to pay by cash or by debit card.
- 7. The damage deposit will be refunded in full upon departure, provided there is no loss or damage to the property.
- 8. Pet(s) may be allowed upon request. You must notify the motel staff upon check-in that you will be staying with pet(s). Failure to do so will result in a \$100/night penalty. Cat(s) are not allowed.
- 9. Noise is not allowed in and outside the guest rooms at any time.
- While we attempt to give at least one warning before an eviction and or calling the local authorities, this policy may be enforced without warning, in order to protect other guest(s) of the motel.
- All noise complaints that result in compensation to guest(s) disturbed will be charged to the guest room whose noise caused complaint.
- All money, deposits, and rents will be forfeited upon eviction.
- 10. Twilight Country Motel is privately owned, and management reserves right to refuse service to anyone. The management will not be responsible for accidents or injury to guest(s) or for loss of money, jewelry, or valuables of any kind.
- 11. Any damage to hotel property or changes to property condition, whether accidental or willful, are the responsibility of the registered guest(s) or affiliated company. Any costs associated with repairs, replacement and/or restoration to original condition (property) will be charged to the credit card number written on the guest registration card or on the credit card authorization form. Otherwise, deductions will be made from the security deposit.
